MAIN PRINCIPLES

- We will endeavour to ensure that all data collected will be processed lawfully, fairly and transparently.
- We will limit to what is necessary for the purpose for which is it processed, keep it accurate and up-to-date.
- We will only retain data for as long as is necessary for the reasons collected.

WHOSE INFORMATION WILL WE HOLD ON OUR DATA BASES?

- Karate students; at our various clubs and school karate clubs
- Visiting students who regularly attend our clubs and events.
- Club instructors

WHAT INFORMATION WILL WE HOLD?

- Members name, gender, age
- Contact phone number
- Members appointed emergency contact name and phone number
- Home address, as provided by individuals for returning licences & renewals
- E-mail address

DATA ON INDIVIDUALS; STUDENTS & INSTRUCTORS

Data on individuals will be used by us for the following purposes: -

- Emergency contact, should an individual fall ill or is injured whilst practicing, competing or representing us. In these circumstances, we will need to notify the individuals assigned emergency contact or if necessary to do so, pass on individuals details to relevant emergency service representatives.
- Notification of events, in order that all members have informed details for training, gradings, competitions, including if applicable travel and accommodation details.
- Squad training and referee courses
- Notification of applicable costs for training, events, travel, accommodation, karate uniforms, clothing, protective gear, syllabus's, training equipment.
- Notification of exclusive offers in relation to training, events, travel, accommodation, karate uniforms and equipment.
- Licence renewal reminders; to ensure individuals maintain an in-date licence so we meet insurance requirements and provide appropriate cover should injury occur where a claim may be warranted.
- Membership renewal reminders; to ensure students renew annually as required. At which
 time from 2019 onwards they will also be required to sign their agreement to our data
 policy. Should individuals fail to renew their membership & subsequently not sign the data
 policy agreement, their details will be removed from our data base and they will no longer
 receive notification of events etc., until such time as membership is renewed and our data
 policy agreement is signed.

DATA ON INSTRUCTORS:

Data on instructors and assistant instructors are held for the following purposes: -

- To ensure they are fully informed of all events within the association, so they in turn may inform their students.
- To gain their assistance on collecting entry details for training, events, courses and competitions.
- To gain their assistance in collecting fees for training, events, course and competitions
- To appoint an instructor to cover a class / classes
- To appoint instructors to participate in training sessions, special courses, events and meetings
- To ensure instructors and assistant instructors aged 18 years and over hold current DBS, instructor indemnity insurance and first aid certificate.
- To make payment for work they carry out on behalf of the association
